

PET STAY AGREEMENT.

I agree to the following rules and conditions when staying at Hotel Mio Puerto Vallarta with my pet:

Only one pet per room weighing 40 pounds or less (18kg) will be accepted. If your pet exceeds the above mentioned weight, they will have to be authorized by the management before accepting the reservation (except for support pets, which will be accepted).

- I agree to keep my pet on a leash in a carrier while in the public area.
- Use plastic bags to pick up your pet's feces.
- I agree to keep my pet away from all areas where food is served (restaurants and bar), including pool areas and common areas.
- I agree to be present when any member of the hotel staff, housekeeping or maintenance, is in the room, room cleaning must be scheduled in advance and occur when the pet is not in the room or the owner is present.
- I agree that my pet will not be given access to my pet if it shows signs of unsolvable conditions or contagious disease, or if it demonstrates aggressive behavior towards others.
- I agree to keep my dog with me or leave a designated person with me at all times.
- I agree not to leave my pet alone in the room.

FROM

- I agree that it is PROHIBITED for my pet to climb on the furniture of the room, as well as to groom him/her inside the room.
- I agree to avoid noise or any other disturbance that my pet may cause to the detriment of other guests in the hotel.
- I agree to pay additional cleaning or repair bills if necessary and authorize the hotel to charge my card for such charges, even after my departure from the hotel.
- If I fail to comply with this agreement, I agree to vacate the premises for breach of this agreement.
